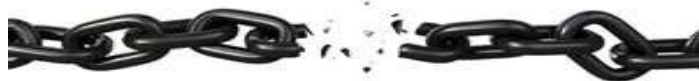

The Mukti Project

is an anti-trafficking ministry in India with goals of raising awareness of the devastation of sex trafficking, combating trafficking in high volume villages in India, rebuilding the lives of those who have been trafficked by addressing their emotional, social, physical and spiritual needs, teaching and training in practical life skills like traditional embroidery, math and literacy, and sharing the hope we have in Christ and the promise of a new life.

All Race Proceeds will go to support the Mukti Project. Your support of the Mukti 5K Run/Walk for Justice will help make an eternal difference in the lives of women and girls at risk and entrapped in sex trafficking.

Registration begins at 7:30 a.m. The cost is \$15 if registered by Sunday, April 8. The cost for late or race day registration is \$20. The cost for walkers is \$10. Registration fee includes beverages and snacks, and a Mukti 5K T-Shirt (guaranteed for those registered by April 8). The course starts and finishes at the church located at 239 Braun Road, Beaver Falls, Pa.
